ICE FEES

FEE SCHEDULE: The following rates will be in effect for the skating season. These fees cover only a portion of the actual cost of the ice rental. Average ice rental rates are around \$120 per hour.

OF = Freestyle open to any level of skater

OM = Moves session open to any level of skater

LM = Moves session open to skaters of Beginner and Pre-Preliminary Freestyle level

LF = Freestyle session open to skaters of Beginner and Pre-Preliminary Freestyle level

HF = Freestyle session open to skaters of Preliminary Freestyle level, and above

HM = Moves session open to skaters of Preliminary Freestyle level, and above.

On Ice Training = a 30 minute class open to all skaters (limit of 15) and taught by the SFSC Head Pro (contracted).

Silver Skates includes 30 minute lesson

Off Ice Class = conditioning class taught by SFSC Head Pro, and signed up for separately (not contracted).

WALK-ON ICE:

Walk-on ice may be available depending on the number of skaters per session. To have your skater's name placed on the walk-on list, sign up on the monitor sheets at the rink. The walk-on ice fees for all sessions except for Silver Skates and 15 minute Moves is \$8 for SFSC home and Associate members and \$9 for all others. The walk-on for 15minute Moves sessions is \$4 for SFSC home and Associate members and \$4 for all others. Walk on fees for Silver Skates is same as contracted rates (see above). Walk-on ice fees must be paid to the monitor prior to getting on the ice. There is no billing for walk-on sessions. Please remember to send money with your skater if he/she is walking-on. If the skater does not have the money to pay the walk-on fees the skater will not be allowed on the ice. One ice session cannot be exchanged for another ice session at any give point. There will be no exceptions to this rule.

Walk-on ice priority is as follows: SFSC members, SFSC Associate members, and Non-SFSC members.

CANCELLATIONS AND COUPONS:

Coupons are issued for cancelled contracted ice sessions. (Note: No coupons are issued for cancelled ice if using the unlimited option). It is the skater's responsibility to cancel ice sessions that the skater is not able to attend by notifying the ice monitor in person or by relaying a message to the monitor via a parent, another skater, or a coach. Such notification should be made as much in advance of the session as possible.

A maximum of six coupons per month per skater are issued for cancelled contracted ice sessions. A "no show" is not considered a cancellation. For the unlimited option, you are allowed no more than 2 days of "no show" per month. Any more than two will be billed to you at the walk-on rate. No coupons are issued for 15-minute sessions. Coupons are issued at the end of the month and are valid for 90 days. Coupons may be used only for walk-on ice and, as such, are subject to ice availability. When a skater uses a coupon to walk-on an ice session, the monitor must record the date and the name of the session on the coupon. Coupons must be given to the monitor prior to getting on the ice. Coupons are not transferable, except within SFSC family memberships.

If a skater cannot skate their contracted ice, **it may not be sold**. If a skater cannot skate due to injury or serious illness, a doctor's excuse is required for a credit or refund. Doctor's excuses must be submitted to the billing agent within 30 days of the missed ice to be valid.
